May 2023 DEP Conservation District Field Rep Talking Points

2023 Growing Greener Plus Grant Round opened on April 21, 2023

Growing Greener grants are designed to improve or protect Pennsylvania's waters from nonpoint source pollution associated with agricultural activities, AMD, stormwater runoff, energy resource extraction, and streambank and shoreline degradation, while Bond Forfeiture grants are designed to address legacy mining impacts.

DEP has identified multiple priority areas for this grant solicitation. Priority areas for Growing Greener grants include projects that reduce nonpoint source pollution – especially nitrogen, phosphorous, and sediment pollution from agricultural and stormwater runoff. DEP is particularly interested in design and construction projects that implement effective Best Management Practices (BMPs) that reduce or eliminate pollutant loadings and lead to local water quality improvements.

One new priority area for Growing Greener grants include Technical Assistance projects featuring public-private partnerships and focus projects on multiple regions or statewide scale with the purpose to expedite on-the-ground, BMP implementation.

Eligible applicants include counties, municipalities, municipal authorities, county conservation districts, watershed organizations, councils of governments, educational institutions, and other authorized organizations involved in water resource restoration and protection. The maximum Growing Greener grant request amount is \$500,000.

New this year, applicants may apply for Stormwater Management Planning (Act 167) grants under the Storm Water Management Act (Act of Oct. 4, 1978, P.L. 864, No. 167). The primary focus of the Act 167 grants is the preparation or revision of Act 167 Plans by counties.

FY2024 Section 319 Nonpoint Source Management Program Grant opened on April 21, 2023

DEP is accepting applications for Section 319 Nonpoint Source Management watershed planning and restoration grants. Priorities for new WIP development is in Pennsylvania's Environmental Justice (EJ) areas, based upon watershed plan elements for threatened or impaired waters.

<u>Model My Watershed Virtual Training</u> - Mark your calendars! DEP's Watershed Support Section and Drexel University will be hosting three, two-part, webinar trainings on Model My Watershed. The training, taught by Dr. Barry Evans of Drexel University, will go over all of the functions of Model My Watershed during the two half-day sessions (approximately 3 hours) to help attendees effectively use watershed modeling for future projects.

This training is mandatory for all Conservation District Watershed Specialists. An official invite will be sent out to districts in the near future.

This training has been broken into three different events in order to allow for a more interactive atmosphere. The training dates for each region are:

- Northwest and Southwest regions: Morning of June 12 and 15
- Northcentral and Southcentral regions: Morning of June 26 and 29
- Northeast and Southeast regions: Morning of July 31 and August 3

DEP asks that you make every attempt to attend your region specific training, however, there will be flexibility to attend a different regional training if calendar conflicts arise. Questions may be directed to Chad Krick at chkrick@pa.gov or 717-772-5706.

Chapter 102 Program

Chapter 102 Basic Technical Training - The Chapter 102 Program, with help from PACD, is offering a Chapter 102 Basic Technical Training, a valuable training for new Chapter 102 staff to provide guidance on program details. Topics at the training include; Chapter 102 Application and Permits, Reviewing a plan and preparing for a site visit, How to Conduct yourself in the Field, E-Permit Reviews, Field Exercises – Site Inspection of Active Earth Disturbance and Final NOT Inspection, Lessons learned from Field Exercises, Panel Discussion – District Challenges. This training is available to new Chapter 102 staff, existing Chapter 102 staff who would like a refresher on program details, and CD managers. The training will take place May 23-26 at the Red Lion Hotel Harrisburg/Hershey. Registration, training agenda, lodging details, etc. can be found on Clean Water Academy, Course: Chapter 102 Basic Technical Training (2023) (remote-learner.net). After logging into CWA, click on the PACD Events and Training Calendar. Participants should also review prerequisite work and review items recommended and required for classroom and field work.

Chapter 102 Listening Sessions - The Bureau of Clean Water (BCW) has started scheduling Chapter 102 listening sessions with the conservation districts again and intend to hold them as a matter of "routine communication" moving forward. BCW hopes to hear district accomplishments as well as concerns during these sessions. They will be held once a month virtually for approximately 2 hours at a time and will contain a group of 2-3 conservation districts and DEP staff. We intend to schedule these calls 2-3 months in advance, so districts should be on the lookout for that invitation over the next year.

Practice Keeper Enhancements Coming in May

Several updates and enhancements will be coming to PracticeKeeper in May.

- The BMP Expiration Report and Upcoming Status Review Report are two new reports that will be coming available.
- The Attachment-G Report, Level 2 Plan Approval Report, and CBP 23 Report will be receiving updates.

These new and updated reports can be expected in the month of May with more enhancements related to Data Explorer, Spatial Data Export, Copy BMP Tool in the Conservation Planning Module, and others will be complete in May or June. A more detailed announcement will be sent to the PracticeKeeper Admins in each CCD and the Conservation District List Serve once the enhancements have been released to production.

Agriculture Compliance Implementation Poll

The Agriculture Compliance Section is conducting a poll to gain insight on the implementation of Agriculture Compliance across the state. This poll is targeted to 102 Delegated County Conservation District's across the Commonwealth. The main goal is to gain knowledge of County Conservation District's complaint response, inspection procedures, and education and outreach regarding agriculture erosion and sediment control. The information gathered from the poll will assist DEP as the DEP Agriculture Compliance Section as we strive to provide guidance for consistent execution of Agriculture-related activities across the Commonwealth. The program intends to distribute the poll in May.

PA Agricultural Conservation Assistance Program (ACAP)

As of March 31, 2023, 65 districts have signed and sent in their agreements. As the SCC has finalized the signature process for the delegation agreements, initial allocations have been processed. Many district should have already received their first allocation and other should be arriving in the district accounts in the near future.

SCC has developed a webpage on the PDA website where they plan to keep updated ACAP information and webinar recordings. The webpage currently has the ACAP Guidelines, SCC BMP List and a draft ACAP Application. Also posted is the past recorded webinars. On April 12, 2023, SCC hosted their ACAP update webinar for CD's. SCC staff provided an update on ACAP GIS, staffing and technical assistance. Many policy questions were raised by districts and will be added to the Q&A document. Roughly 80 attended the webinar.

SCC staff intend to continue monthly webinars for all District managers for the foreseeable future.

ACAP Workgroups Continue

The ACAP Advisory Workgroup reviews draft documents and provides input on new policies in the program. The ACAP Advisory Workgroup was very key in the development of the Setback Policy and will now move forward in discussions about Bidding policies.

The ACAP Center Subcommittee continues to discuss the Center and the expansion of Boot Camp Trainings. Jennifer Fetter of Penn State will be spearheading the development of the Center, which includes laying out the framework and building staff capacity. SCC plans to meet with Penn State to discuss the needs of State Engineering as well as other outputs.

The ACAP Technical Assistance Workgroup advises on the task of Trainings for Technical Assistance as well as technical support across the state. This group met on February 22nd to discuss engineering, RFPs, Job Approval Authority, Certifications for BMPs and Admin Training. With the development of the Center starting to take shape, SCC anticipates this group to reconvene to discuss the actual needs for districts state-wide on a more regular basis.

SCC has formed an Engineering Workgroup consisting of District Engineers, District Techs and SCC. This group are in discussions of the building blocks of a state run engineering program that will allow SCC to develop their own Job Approval Authority. This group is meeting every two or so weeks. The group has determined that the state does need their own system with at least one State Engineer housed or working with the new Center. Regional support is going to be key so the group continues to discuss how to regionally support the districts.

Senator Scott Martin is a lifelong Lancaster County resident with deep roots in the community. He was elected to his first term representing the 13th Senatorial District in November 2016 and re-elected in 2020. From that day on he has been a "friend" of the Conservation District.

Scott currently serves as Chair of the Senate Appropriations Committee, which plays a crucial role in negotiating and developing the state budget and is responsible for reviewing all legislation for its fiscal impact. Scott is also an active member of the Environmental Resource & Energy and Game Fisheries Committees.

As Chairman of the Appropriations Committee, Scott has been a strong advocate for conservation efforts across the state. In 2021-2022, Scott worked with another friend of Conservation Districts, Senator Gene Yaw, and others to sponsor Senate Bill 832. Once enacted, this legislation created the PA Clean Streams Fund which utilized ARPA dollars to increase support for existing State agricultural programs as well as creating the new statewide Agricultural Conservation Assistance Program (ACAP). ACAP represents a statewide investment of \$154 million that will be directed specifically by the State Conservation Commission and county conservation districts to help improve water quality and soil health.

Indicative of Scott's leadership style, he recently shared that "although Republicans spearheaded these key environmental protection measures, it is noteworthy that they were also supported strongly by Democrats as well". Scott believes that this approach reinforces a simple basic truth, "we achieve our best results when all parties set aside partisanship and work together for the good of the people we represent".



Conserving Natural Resources for Our Future

Outside of his regular Senate responsibilities, Senator Martin also serves as Chairman of the Chesapeake Bay Commission (CBC). The CBC is a multi-state agency that has made tremendous progress in promoting legislation and funding for restoring our waterways throughout Pennsylvania, Maryland, and Virginia. Scott reinforces that there is no room for political agendas or one-sided talking points for this panel, but he remains a strong advocate for Lancaster County as well as all of Pennsylvania.

In 2022, Senator Martin co-hosted a 3-day meeting/tour in Lancaster County for the full commission highlighting the extensive conservation and watershed restoration work that is happening.

As Chair of the Commission, Martin continues to play an active role in working with state and federal environmental officials, legislators, and business owners within the Chesapeake Bay watershed to support our efforts to meet federal pollution reduction goals.

For these reasons and more, the Lancaster County Conservation District Board of Directors is pleased to nominate Senator Scott Martin for the PACD 2023 Legislative Leadership Award.

EPA Assessment Update

LCCD Ag staff participated as landowner advocates in EPA's Conservation Assessments Initiative (PACAI) last week. The attached PACAI Summary and FAQ Sheet are resources provided to answer questions about EPA inspecting farms in the county. Additional assessments will be conducted during the second week of May.

The attached letter/email was sent to all elected officials to explain our local perspective of the PACAI.



Pennsylvania Conservation Assessment Initiative Frequently Asked Questions

Why is the EPA doing this PA Conservation Assessment Initiative?

The goal of these assessments is to identify, assess, and address significant pollution discharges to help PA meet its water quality goals for local streams and the Chesapeake Bay.

What Is EPA looking for during the assessments?

EPA is assessing farms that have the potential to contribute significant amounts of nutrients and sediment to local streams and the Chesapeake Bay.

What is EPA's regulatory authority to conduct these assessments?

The Clean Water Act Section 402 and its implementing regulations provide the authority for EPA to conduct these assessments to determine whether an animal feeding operation is discharging pollutants to regulated surface waters.

How many assessments will be conducted in Lancaster County?

EPA plans to conduct approximately five assessments in April and May.

How were farms selected?

EPA is following available data to select farms for assessment. Criteria include location, proximity to impaired waters, potential downstream impacts, and potential impacts on drinking water. These farms will be small or medium operations that currently are not covered under the federal CAFO permitting program.

Will farmers be notified in advance of the visits?

Yes, EPA will give the farmers advanced notice of the assessments. EPA is coordinating with the Pennsylvania Department of Environmental Protection, Pennsylvania Department of Agriculture, the State Conservation Commission, and the Lancaster County Conservation District.

What will happen if the operation is contributing to water quality issues? Will EPA designate small farms as CAFOs?

If EPA finds water quality issues, we will work with the state and local partners to connect them with funding opportunities and technical assistance to address the water quality issues. If the operation is a significant contributor of pollutants to the local stream and impacts downstream waters and does not take steps to mitigate its discharge, EPA has the authority to designate the farm as a Concentrated Animal Feeding Operation (CAFO) and require them to get a National Pollutant Discharge Elimination System (NPDES) permit.

How will the assessment data results be shared and used?

EPA Region 3 will share reports of our findings with the farmer and state agencies and will post a non-confidential summary of our activities on our website.

Will a local representative be available as a landowner advocate?

Yes, an agricultural technician from the Lancaster County Conservation District will be on site to answer questions during the assessment.

What resources will be available if any corrective actions are required?

Depending on the issue, a variety of technical services and financial resources may be available to the landowner such as Pennsylvania's Agriculture Conservation Assistance Program and Conservation Excellence Grant program.

What happens if a farmer does not correct the water quality issues?

If the operation is a significant contributor of pollutants to the local stream and impacts downstream waters and does not take steps to mitigate its discharge, EPA has the authority to designate the farm as a CAFO and require them to get a NPDES permit.

How much time will be available to the landowner to correct any issues?

There is no specific timeframe required as we realize making significant changes can take time. The expectation however is that issues should be corrected as quickly as possible. The Lancaster County Conservation District and other State and local partners can prioritize the farm for the necessary technical and financial resources to address the issues.

What is the long-term benefit for the landowner and community as a result of the assessments?


Many farm families are doing what is right to help protect the environment and their neighbors downstream. This initiative will help identify those operations with water quality issues and connect them with funding opportunities and technical assistance to address the issues. Everyone benefits when our local waters are cleaner. Farmers' conservation actions not only improve the quality of local streams, but also the quality of waters downstream like the Chesapeake Bay. Operations that are well-managed and compliant with environmental regulations are more sustainable.

What is the Pennsylvania Conservation Assessment Initiative?

Beginning in April 2023, Environmental Protection Agency (EPA) Region 3 will assess animal feeding operations on certain small or medium-sized farms in Lancaster County, Pennsylvania to identify and address water quality issues impacting Pennsylvania streams.

Identifying, and addressing significant pollutant discharges from these farms will:

- help Pennsylvania meet its water quality goals for local streams and the Chesapeake Bay
- improve water quality for downstream users
- help farmers keep nutrients and sediment on the farm where they can do the most good



PA streams not attaining water quality standards

How did EPA choose the farms to assess?

EPA Region 3 analyzed data and identified farms that have the potential to significantly pollute local streams and the Chesapeake Bay. The criteria used to identify farms for assessment included proximity to impaired waters, likelihood of downstream impacts, and potential impacts on drinking water. The farms to be assessed are currently not covered under the federal Concentrated Animal Feeding Operations (CAFO) permitting program.

What will happen if we find water quality issues?

If we find water quality issues, EPA Region 3 will work with state and local partners to help connect farmers with funding opportunities and technical assistance to improve conservation practices. If the farm does not address the water quality issues, we may determine the farm needs a permit to protect water quality.

What resources are available for farmers if opportunities for improvement are identified?

EPA Region 3 is committed to help improve water quality on farms that need it by connecting farmers with state and local funding resources. For example, the Clean Streams Fund's Agriculture Conservation Assistance Program provides \$154 million statewide for farm conservation practices that reduce nutrient and sediment pollution in Pennsylvania's local streams.

Good afternoon Senator,

I am sure you have heard that EPA about the Chesapeake Bay Foundations Settlement Agreement with EPA (see attached), but I wanted to also make sure you also knew that EPA has been in the County conducting Conservation Assessments in the Southern end of the County. EPA has been quick to say the assessments and the settlement are separate issues, but I think the attached Factsheet and Q&A are good resources for answering many questions about what to expect from the settlement.

As a follow up about the Assessments, EPA conducted 2 farm inspections last week and have planned to do 3 more in May. District staff have been on site and acted as a landowner advocate to help interpret questions and answers between EPA and the farmers. This has been a much more collaborative exercise then what was conducted in Watson Run back in 2010 and EPA has discussed preliminary "observations" they found during the assessment regarding farm and manure management. The analysis of the water samples taken from adjoining streams is still pending and will likely determine further action.

As for the settlement, my gut reaction, this is a shot across the bow. A warning that we (Pennsylvania) are not on pace to meet the goal. Based on conversations with EPA, DEP and PDA the settlement is more than an empty threat and it will push the Federal and state agencies to do more, but with that will come more funding to help our farmers comply with regulations. I actually view the EPA Assessments and Settlement as a needed wake up call. We have been discussing the Backstop Options (see attached, 2nd page) that EPA could impose to force PA to do more to reduce pollutants getting to the Susquehanna River since 2015-16...it is what led to the formation of our Lancaster Clean Water Partners. I believe EPA has been slow to enact these consequences in PA because there are a lot of good things happening ...especially in Lancaster County. We have many new valued partners working toward a common agenda for clean water, 3,800 farmers out of 5,100 who we know have taken first steps forward to helping clean up Lancaster's waters, there are strategic initiatives to address whole watersheds, etc....but there is still a lot of work to do and a lot of landowners and businesses that are still resisting doing their part. Without the added push by the regulators they will keep waiting.

To date, EPA and DEP have actually been very supportive partners with the Lancaster effort. Over the last 3-4 years, we have been in near constant contact with both agencies. We don't always agree with what they want us to do and we push back, but then are able to collaborate to find a way forward.... and they both have responded with significant funding increases for BMP implementation of approx. \$2-\$3million each year. The new ACAP program (thank you very much) is giving Lancaster another \$15 million over the next 4 years. We already have \$1.4 allocated, but at this point, we need to be doing more at every level. As we get closer to 2025 (deadline for some of the Bay clean up goals), the pressure will only increase and if we can't document progress because of landowner and business inaction it will result in significant and what I believe to be detrimental impacts of EPA's backstop options.

We will keep you posted as this develops and glad to discuss further if you have any other questions. Chris
